

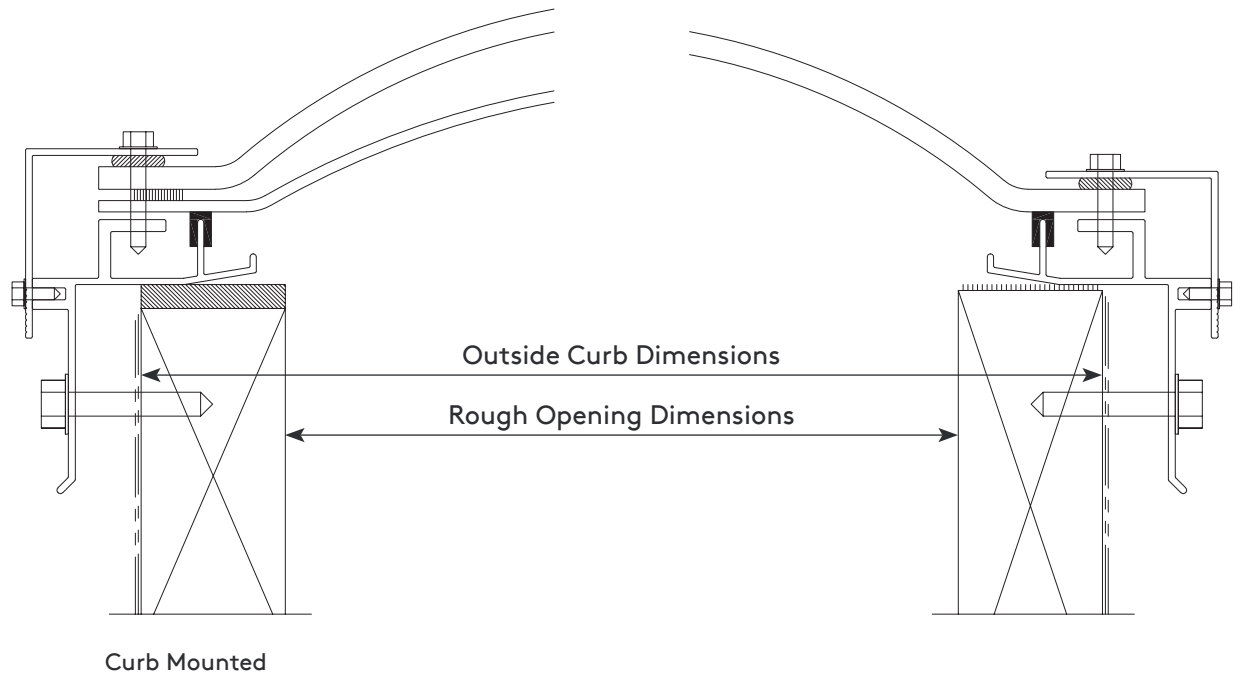
Heavy Duty Polycarbonate Unit Skylight Product Data Sheet

Tornado + High Velocity Hurricane Zone (HVHZ)



Application

The skylight shall be fully factory assembled consisting of a 0.177" thick polycarbonate dome with a CC-1 classification that is sealed by interior and exterior gaskets. The skylight frame is fabricated from 6063-T5 heliarc welded aluminum. The frame is to have an integral condensation channel to carry moisture to the exterior. The vertical aluminum retaining cap fasteners are to be stainless steel #10-14 x 1" lg. hex head self drilling screws with neoprene washers at 6" centers. The horizontal aluminum retaining cap fasteners are to be stainless steel #10 x 3/8" lg. hex head sheet metal screws at 6" centers. 1/4" Galvanized lag screw curb fasteners, by others, attached at 9" centers. The skylight frame shall be installed on a 1-1/2" wide curb furnished by others. An optional aluminum self flashing curb has a 3" roof nailing flange and varies in height from 6".

Warranty

For a period of ten (10) years from the date of purchase, Kingspan Light + Air warrants that Tuffite Polycarbonate skylights will be free from defects in material and workmanship and that no water will leak through the commercial curb top or self flashed skylight. This warranty also includes coverage against documented 2" hail stones or smaller as well as cracking or crazing of polycarbonate dome material that would result in a water leak. Exceptions apply, see 10-year warranty document.

IMPORTANT SAFETY NOTE:

The owner must take steps to protect personnel who may be in the area of the skylight or smoke vent. The owner should restrict access only to authorized personnel who have been adequately cautioned as to the location of the skylights or smoke vents and informed of the warnings below. Because there is a risk of fall and resulting personal injury, we recommend protective guardrails, internal safety screens or external cages around all skylights and smoke vents, as well as the use of fall restraint systems. We also recommend that skylights and smoke vents are inspected annually for evidence of damage, such as cracks or penetrations. Any damage should be repaired immediately, and the area beneath the skylight or smoke vent should be safeguarded against falling objects.
